## 3. Approval of previously circulated minutes

The minutes were approved and signed.

**Additional item - Report from M40CEG –** John Howell MP has written to Tom Harris MP at the Department for Transport. Tom Harris is on parliamentary recess.

A re-working of the plan of works is required. There will apparently be some cost savings, which could go towards the cost of noise abatement. More meetings are proposed with Highways Agency and John Gardner, the site manager.

One of the points at issue is that not enough people live in Milton Common for costs of noise abatement to be justified, although estimates for costs for noise reduction prepared by M40CEG are dramatically lower than official estimates

## 4. Matters arising from previous minutes

a. Affordable Housing, Station Yard – The sub-committee had not met since the last Parish Council Meeting. A letter dated 11 August had been received from Adrian Duffield at SODC Planning and Building Control Services, reiterating his conclusion not to revoke the planning permission. A meeting of the sub-committee is to be held to consider this letter. No time line is known for proposed start of the development.

- b.(i) and (ii) Pelican crossing and traffic island Mr Price offered to speak to police about this matter.
- c. Commemorative tree we await further details re plaque, ceremony and watering arrangements.
- d. Chestnut tree Clerk to contact Judith Osborne, Arboricultural and Landscape Manager at Oxfordshire Highways to reiterate that chestnut tree is dead and should be felled.
- e. Risk assessment Mrs Willis was thanked for her written report. The various matters covered by the report were discussed and this item to be on agenda for September meeting to discuss progress and action needed.

## 5. Open discussion

Mrs Willis asked about emptying of rubbish bins in play area – apparently this is something for which we are responsible.

Speed display unit hire – to be on agenda for next meeting for consideration.

Oxford Partnership draft Sustainable Community Strategy for South Oxfordshire – consultation questionnaire needs to be returned by 22 September 2008. To be on agenda for September meeting.

We still have not received consultation document re flooding situation. Clerk to telephone Oxford Highways to determine a way forward.

Mr Price reported that telephone directories can be put in paper recycling boxes.

Mr Field said that rubbish is being put in hedge in Ickford Road. Clerk to draft letter to residents and article to be put in next newsletter.

Mrs Horne again mentioned the water constantly running down Sandy Lane. Clerk to contact Highways at SODC.

The patching of potholes has not been done well enough. The state of repairs at the Lantern Station was particularly bad.

Burning of rubbish within 50 feet of centre of highways can be reported to the police.

The roadside trees and bushes from Sandy Lane turning to the Belfry Hotel need attention. Clerk to write to OCC Highways.

Mr Nowell-Smith said that 2 way timetables are needed in bus shelters.

There are potholes in lane to Albury church. Clerk to write to OCC Highways.

P08/W0792 – Chenar Oxford Road Tiddington – Raise existing ridge height and provide additional accommodation. Convert existing garage and new conservatory to the rear. Approved.
