#### **MINUTES**

- **2. Declarations of interest:** Mrs C Draper re Albury Lane.

### 3. Approval of previously circulated minutes:

The minutes were approved and signed with one minor amendment.

# 4. Appointment of Chairman and Vice-Chairman:

The Clerk took the chair and Mrs E Horne was re-elected Chairman (proposed Mrs Knight and seconded Mr Field) and Mrs C Draper was re-elected Vice-Chairman (proposed Mr Price and seconded Mr Savell).

# 5. Allocation of Councillors' responsibilities:

The Council determined that these should remain as before. Responsibilities to be considered for some refinement.

# 6. Matters arising from previous minutes:

- a.Pelican crossing in village Clerk has spoken to Thame Town Clerk re request for allocation of S106 monies from Thame housing development. Town Clerk has said that any decision will not be made until July at earliest. To be on agenda for next meeting.
- b. Albury Lane –Clerk has contact contractor, George Ayres, regarding price for attention to potholes and has been told that there will be approximately 8% price increase due to rising cost of bitumen. Time-scale for work to be done will be next few weeks. Clerk to contact contractor to put work in hand. Clerk also to obtain price for tarring and chipping of upper part of lane.

Clerk to write strong letter re potholes/drainage matters in Parish.

Clerk to obtain written confirmation that Albury Lane is Council property. To be on agenda for next meeting.

- c. Drainage works in village Clerk has contacted Daniel Depp from Oxfordshire Highways, who has said that he is conferring with Keith Stenning. To be on agenda for next meeting.
- d. Purchase/planting of daffodils in Parish consideration to be given to this in autumn.

P13/S0514/FUL – Walters Farm, Sandy Lane, Tiddington OX9 2LE – Two storey side extension and single storey side extension. Planning consent granted by SODC.

P13/SO959/HH – 26 Ickford Road, Tiddington OX9 2LR – Demolition of existing conservatory. Erection of new single storey rear extension and raised decking area. To be recommended for approval.
